Sub:- Regarding visit-2022 of pilgrims at Shri Amarnathji Shrine (J&K).

With reference to your D.O letter no. CEO/SASB/2021/1004 dated 14.12.2021, on the subject cited above.

It is informed that in compliance of recommendations of Special High Power Committee (SHPC) to look into the mortality of pilgrims visiting Shri Amarnathji Shrine (J&K), constituted as per orders of Hon'ble Apex Court in Writ Petition (Civil) no. 284/2012, the Health Department, Govt. of Haryana has taken following actions :-

Note:- (i). If Physician/Orthopaedician is not available in Sub-Division Hospitals, they may be deputed from other Health facilities of district or cases may be referred to the District Committee.

(ii). Civil Surgeons are requested to ensure that the doctors shall write their Name and Medical Council Registration Number while issuing the Compulsory Health Certificate (CHC) at the appropriate places indicated in the enclosed format of CHC and shall not leave blank any section of CHC.

2. Private hospitals are not authorized to issue medical certificate (CHC).
